All facilities must have secondhand smoke prevention measures based on the Health Promotion Act.



Type I facilities

Targeted facilities ▶ Schools, hospitals, pharmacies, child welfare facilities, government office buildings, etc.



In principle, no smoking on the premises*

*As an exception, installation of designated outdoor smoking areas outside the building is permitted.

Necessary measures for setting up smoking areas:

🕠 Partitioning of smoking area 🙋 Indicating with labels that it is a smoking area 🔞 Setting up in places where users normally don't enter









Type II facilities

Targeted facilities Restaurants, offices, factories, hotels, etc. (Other than a type I facility or facility for smokers*)

*Bars and snack bars where the one of the main purposes is smoking, tobacco shops that allow smoking indoors, etc.

Requested measures

In principle, no smoking Including non-public in indoor areas

rooms and other facilities only used by employees

As exceptions, the setting up of smoking rooms that fulfill criteria, as well as transitional measures for small restaurants (provided that they have been operating as of April 1st, 2020) are allowed.



Technical criteria for setting up smoking rooms

- In the entrance, the flow of air coming in from outside to inside must be 0.2m or more every second
- Must be partitioned with walls, ceilings, etc. in order to prevent tobacco smoke from flowing out of the smoking room
- Tobacco smoke is ventilated outside or to an external area



Types of smoking rooms

- Designated smoking rooms: eating and drinking not allowed.
- Thermal tobacco smoking rooms: eating and drinking allowed.

Requirements for restaurants subject to transitional measures

People under 20 years of age are not allowed to enter the smoking area

People under 20 years of age can not be allowed to enter the smoking area even if they are employees. For facilities where smoking is allowed*, people under 20 years of age are not allowed to enter.





*Restaurants that allow smoking in all areas inside, among small restaurants subject to transitional measures

Obligations to be considered are designated in the **Health Promotion Act.**

Considerations when setting up Obligations of facility managers smoking areas outdoors

When setting up smoking areas outdoors, facility managers have an obligation to carefully consider the location in order to avoid causing unwanted secondhand smoke in the area.

Example Do not set up smoking areas near sidewalks with a lot of people coming and going, near entrances of stores, or places where a lot of people gather.

Considerations when smoking outdoors Obligations of smokers or in personal residences



Even when smoking outdoors, in residences or on balconies, smokers have an obligation to take care of their surroundings in order to ensure that unwanted secondhand smoke does not occur.

Example Do not smoke in places with many people coming and going. Do not smoke near children. Do not smoke on balconies.

Obligations of people who manage facilities

- Do not set up smoking tools or equipment such as ashtrays in places where smoking is forbidden.
- When setting up a smoking room in your facility, post a label that indicates where the smoking area is at the entrance of the place where smoking is allowed as well as the main entrances and exits of your establishment.

(Also required for non-smoking establishments)

- *Obligations based on Kanagawa Prefecture regulations
- When setting up a smoking room in your facility, the construction and installation of smoking rooms must conform to technical criteria for preventing the outflow of tobacco smoke.
- People under 20 years of age (including employees) cannot enter places where smoking is allowed.
- For people who smoke or are trying to smoke in places where smoking is forbidden, they are requested to either stop smoking there or to leave the area.
