1. Basic Charge (from 08:31 hrs. to 16:30 hrs.) (yen)

Notes:

- (1) The Vessels exceeding G/T150,001 shall be additionally charged ¥2,700 per every G/T10,000 or fraction thereof.
- (2) If the ship needs more than standard numbers of laborers, the extra charges shall be decided each time by the agreement between the concerned parties. The charge shall be decided according to the number of the laborers, and is based on the wages of extra laborer as stipulated in the Yokohama Port Stevedoring and Transportation Tariff
- (3) The charges for mooring and unmooring work to the ship which is alongside the pier is a 50% addition of the basic charges listed above. The reception procedure is as follows:
 - Reception hours:** by 15:00 hrs. of the previous day
 - Working hours:** from 07:30 (start mooring) to 18:00 (finish mooring and leave the ship)
 - Shifting of the mooring ships:** we don't accept the continued shifting work of one mooring ship to another mooring ship

2. Additional charges

(1) Out-of-hours

From 16:31 – 22:00	60% addition of the basic charges
From 22:01 – 06:00	110% addition of the basic charges
From 06:01 – 08:30	70% addition of the basic charges

(2) Sundays and Holidays

For Sundays, National Holidays and the year-end and New Year holidays (Dec.31 to Jan.3), 100% addition of the basic charge shall be applied. However, as for Year-end & New Year Holidays, the additional charge shall be handled provisionally as of Dec. 1, 2003.

In addition, for ships which are given reduction or exemption of the wharf usage charge, applied to ships docking at wharves at the Port of Yokohama on Sundays, the additional charges shall be 70% addition of the basic rate in line with the incentive system of the Port of Yokohama.

(3) Rainy or snowy weather

30% addition of the basic charge.

(4) Shifting

In case of shifting the ship on the same pier, if the mooring hawsers are carried over 75 meters by laborers on the pier, a 60% addition of the basic charge of mooring only.

3. Waiting charges

(1) Mooring

30% addition of the basic charge (when the work becomes overtime, the overtime extra is added) per hour and fractions thereof is charged, if laborers must wait more than one hour reckoned from the appointed time to start the mooring work outside the harbor.

(2) Unmooring

30% addition of the basic charge (when the work becomes overtime, the overtime extra is added) per half an hour and fractions thereof is charged, if the unmooring work cannot be started after waiting more than half an hour reckoned from the appointed time.

4. Cancellation penalty

In case of canceling the work after the arrangement time mentioned below, 50% addition of the basic charge (when the work becomes overtime, the overtime extra is added).

(1) Weekdays

Canceling time for the ships entering and leaving between 18:30 of the day and 08:30 of the next morning is by 16:00 of the day.

(2) Sundays and Holidays

Canceling time for the ships entering and leaving on Sundays and holidays is by 16:00 of the previous day.

(3) any other cases

① In case of informing the changes of the appointed time after half an hour prior to the appointed time of leaving or entering the port, the arrangement in advance is canceled.

② After the arrangement time mentioned above (1) and (2), the ships leaving or entering the port from 18:30 of the day to 08:30 of the next morning change the leaving or entering time to after 08:31 of the next morning, the arrangement in advance is canceled.
