15% discount on entrance fee of port dues

Financial Incentive for environment-friendly ships

➤ Applicable Vessels

- ① All sea-going vessels which score 30 points or more on the Environmental Ship Index(ESI)
- ② All Green Award Foundation certified sea-going vessels

➤ Description

15% discount on entrance fee of port dues

➤ Required Documents

- The Copy of Certificates of ESI or Green Award (How to obtain Certificates, Please see Page 4.)
- Application form of the discount on entrance fee

➤ Application Method

- Please submit the Application form with the Entrance Notice
- Applicants are Ship owner or Agency
- Please submit to Yokohama Port Corporation by FAX (+81-45-521-8081)

➤ Important Notice

You can't apply for the Financial Incentive, using the Certificates which becomes expired (Japan time)

➤ When you can take other incentive programs...

You can enjoy every incentives (The maximum is 100% discount).

➤ Example



Sea-going vessel B entered KEIHIN 3 ports
Gross tons 40,000tons ESI score 32.0
Green Award Foundation Certified

Sea-going vessel A
Gross tons 90,000tons ESI score 32.0

Incentive for vessel A (entrance fee)
basic fee 90,000tons × JPY2.7 = JPY243,000
discount JPY243,000 × 15% = JPY36,450
Amount JPY243,000 - JPY36,450 = JPY206,550

Incentive for vessel B (entrance fee)
basic fee 40,000tons × JPY2.7 = JPY108,000
discount(3 ports) JPY108,000 × 2/3 = JPY72,000
discount(ESlorGA) JPY108,000 × 15%* = JPY16,200
(※If you certified by both ESI and GA, you take only 15% incentive.)
Amount(you pay)
JPY108,000 - (JPY72,000 + JPY16,200) = JPY19,800

The aim is to achieve a genuine reduction in emissions of NOx, SOx and particulates, as well as CO2 in the longer term, to be achieved by initiating changes in behavior among ship owners/operators and ports.

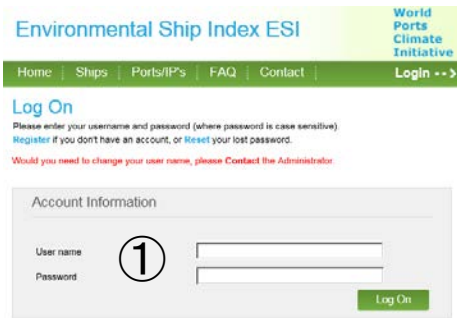
➤ How to obtain the Certificate
