

## **Greetings at the start of 2019**

Happy New Year, everyone! I earnestly hope you have entered the new year in safety and good health. This year, Yokohama will be celebrating the 160th anniversary of the opening of its port, and there will be a stream of events that will further heighten Yokohama's stature as an international city. We are determined to make 2019 a fruitful year in which Yokohama makes another leap, with your assistance.

Yokohama will be the venue of the Seventh Tokyo International Conference on African Development in August and see the opening of the Rugby World Cup 2019TM in September. It will be the site of seven matches in this event, including the final. At the same time, we are going to hold Yokohama Otomatsuri 2019 to heighten our city's vitality and link this to the Tokyo 2020 Olympic and Paralympic Games. As part of Garden Necklace Yokohama, we will be holding a new program titled "Yokohama Rose Week" and taking other action to foster inclinations for nurturing the growth of flowers and greenery. This will likewise add momentum to our efforts to attract the International Horticultural Exposition to the former site of the Kamiseya Communication Station.

Our Medium-Term Four-Year Plan 2018 – 2021 formulated last year is imbued with our resolve to take full advantage of these opportunities to make Yokohama a city whose residents feel safety, security, dreams, and hope, long into the future. As Yokohama is one of the SDGs Future Cities, we are incorporating SDG perspectives into all sorts of initiatives. We are going to take measures for fuller arrangements in the areas of childrearing, education, welfare, and medical care, and for achievement of a symbiotic society. We are also doing all we can to stimulate the Yokohama economy and prepare for earthquakes, torrential rains, and all other types of disaster.

This year will also see the opening of the Shinko No. 9 passenger liner terminal and facilities for accommodation of passenger liners on Daikoku Pier. In addition, work is progressing on the new City Hall building and Pacifico Yokohama North, which are scheduled to be open next year. #### Formulation of the Promotion Plan for the Yokohama City Master Plan For General Waste Management (2018 – 2021) (Yokohama 3R Dream Plan)

## Think about it – the garbage you produce every day

#### Concept

We are taking all viable approaches toward the goal of achieving a recyclingoriented community in a distinctively Yokohama way.

In promoting these approaches, we value the 3R actions taken by our citizens and businesses on their own initiative.

#### Reduce

reducing waste volumes

#### Reuse

reusing resources over and over

Recvcle sorting waste so it can be used again after transformation back into a resource

#### **Basic targets**

Reduction of the total amount of garbage and resource waste by at least 3% (as compared to fiscal 2017)

Over the eight-year period under the preceding plans, the total amount of waste was reduced by 5.3 percent. We are taking aim at an additional reduction of at least 3 percent over the next four vears.

The plan also includes the reduction of greenhouse gas emissions accompanying waste disposal by at least 25 percent as a basic target.

Yokohama formulated the Promotion Plan for the Yokohama City Master Plan For General Waste Management (2018 - 2021) in order to reduce the total amount of garbage and resource waste, and greenhouse gas emissions. The plan contains specific measures to be implemented from fiscal 2018 to fiscal 2021.


#### Strategic targets

**Reduction of food loss generated** by households by at least 20% (as compared to fiscal 2015)

We are taking priority approaches to reduction of food loss, which accounts for about 60 percent of the kitchen waste from households.

We are also aiming for an increase in the amount

of power provided by incineration plants by at least 5 percent (as compared to fiscal 2017).



#### **Food loss**



In Yokohama, food loss amounts to about 30 kilograms per year per citizen (this may be equated with about 300 onigiri per person!). Even households whose members believe they are not wasting food actually have significant food loss. Try and reduce food loss in your home, and begin by doing what you can!

#### Three things you can do right away to reduce food loss




Check the food in your refrigerator before you go shopping, and buy only what you need, in the needed amount.

#### Keep the contents of your refrigerator in good order

Keep the contents of your refrigerator in good order, and note expiration and "bestbefore" dates on items.

#### Make only amounts that will be eaten

Make meals only in amounts that will be eaten in one sitting. If there are any leftovers, skillfully preserve them in the refrigerator or freezer.



#### **Plastic waste**

Marine pollution due to plastic waste has become a serious problem worldwide. Plastic waste littered on streets, etc. is carried into rivers by wind or rain and flows into the sea. Make

sure to never litter plastic waste and to discard it in waste containers especially for plastic. It may also be noted that the sorting rate for plastic containers and packaging waste from households in Yokohama is only about 60 percent. It is vital for citizens to obey the sorting rules.

#### Three things you can do right away on the problem of plastic waste

#### **Discard plastic waste in** bins especially for it

Product wrapping and container waste made of plastic in the home are to be discarded as "plastic containers and packaging."



Discard waste PET bottles in bins for cans, bottles and PET bottles



Containers for mayonnaise and fermented beans are also types of plastic containers and packaging.



Cushioning materials that protect products, shampoo bottles, and containers for fermented beans, etc. are also types of plastic containers and packaging. Before discarding them, remove grime by rinsing them with water.

Get a personal shopping bag and do not take plastic shopping bags at the checkout counter.

> Avoid buying disposable plastic products, as far as possible.







### Put waste into waste bins



Begin by doing what you can.
